- Emergency Preparedness Coordinator confirmed a Closed POD partnership with Streck Labs, and assisted their company with preparing operational plans to receive medical countermeasures.
- Safe Kids Sarpy/Cass was awarded \$7,500 from DHHS as part of the Preventative Health and Health Services Block Grant. Activities funded under this opportunity include an increased access for Cass County residents for child passenger safety seat installations and brain injury prevention awareness activities.
